SATOP:

The Substance Abuse Traffic Offender Program (SATOP) is a statewide network of comprehensive, accessible, community-based education and treatment options for consumers arrested in Missouri for alcohol- and drugrelated driving offenses. This network includes an assessment screening process and referral to various SATOP education and treatment programs. These programs are regulated by the state and likewise the fees are set by the state and thus subject to change. Listed below are the steps and the programs of SATOP (note: <u>financial assistance may be available</u>):

Step 1– Screening

Every individual who is assigned SATOP must have a screening/assessment. Fee \$375
