

Missouri State University offers ten (10) Community College Scholarships to OTC transfer students. This is an MSU scholarship – MSU funds the scholarship and selects the final recipients based off of a recommended list provided by OTC Chancellor Dr. Higdon.

The recommended list of candidates is due to MSU by May 1st, 2018. In order to review applications and submit the list of candidates to MSU, prior to the May 1<sup>st</sup> recommendation deadline, **OTC student applicants must submit the below information to OTC's Financial Aid Office by April 1<sup>st</sup>, 2018.** Applications will not be considered if received after the April 1<sup>st</sup> deadline.

To be eligible to apply for consideration, the following requirements must be met:

1. Be currently enrolled at OTC
2. Have completed at least 42 credit hours at OTC
3. Have a minimum cumulative GPA of 3.40
4. Be transferring to MSU in the Fall semester
5. Submit your application, essay, and two letters of reference (Academic references preferred) to the OTC Financial Aid Office by April 1<sup>st</sup>, 2018
